3. Agreeing the Minutes of the Last Meeting.

Cllr Conlin and Cllr Hayhurst attended the Joint Liaison meeting on behalf of Kilham Parish Council. Many issues were raised at the meeting which affect all the local parishes including speeding through the villages. Cllr Conlin highlighted a concern that there were no 30mph repeater signs on Back Lane. The parish has since been informed that this work has been added to this year's work programme.

Cllr Hayhurst raised concerns that there were limited footpaths around the new developments; this has since been resolved by the developer resubmitting plans incorporating new footpaths around the development.

Cllr Horner gave a presentation to the village hall committee regarding the installation of Broadband in the hall. The costs were £360.00 plus a one off payment of £80 for the installation. The village hall committee were in agreement that at represent the facility was not required. A resolution was agreed that the parish council were prepared to award a grant to the village hall to cover the above costs as it was felt that it would greatly benefit both the village hall and its current user groups, proposed by Cllr Buckle and seconded by Cllr Hayhurst, all in favour.
