### Highways- To raise any issues

The potholes at the entrance of Pasture Close and Berrimans have been filled but ERYC have left heaps of tacmac. Clerk to contact the highway department and express the parishes disappointment. There are potholes on the bend of Harpham Lane.

Darley Close footpath is overgrown with moss, ERYC have sprayed the area but the dead moss is still causing a hazard.

The footpath around the Burton Road development still has not had any dropped kerbs added.

**Tree Review** - To discuss hiring a tree surgeon to review the trees within the church yard/pond area/playground/cemetery and decide thereon 251/20

A resolution was passed for Advanced Trees and Grounds to assess the trees in question and report back to the Clerk. If any trees are highlighted as in need of trimming or diseased, clerk to submit a planning application to ERYC and obtains a quote. Proposed by Cllr Marshall and seconded by Cllr Woodward, all in favour.

Police and Crime Plan – To receive an update from Cllr Oxley

Cllr Oxley reported from the meeting with the police. Half the police's budget goes on drug county line prevention, modern slavery. Green Laning/ drones and fly-tipping are all on-going issues. It was recommended that people down load the app 'What three Word', if you are asked to give a location and you do not know where you are, this app will give the emergency services an approx area to start looking.
