Mrs Knaggs reported that the KPFA are working in partnership with Humber Forest on a proposal to extend the existing footpath, to create a one-mile track, with the overall aim of improving accessibility. The plans also includes the creation of a healing and reflection area, along with a sensory garden. All elements of the project are expected to be fully grant funded.
