# Agreeing the Minutes of the Last Meetings.

The minutes of the 08<sup>th</sup> September 2025 meeting were agreed to be a true record and duly signed by the Chairman. Proposed by Cllr Tanner and seconded by Cllr Horner, all in favour.

Public Forum 1494/25

Members of the public were present to support the retarmacing of the old cemetery path. The Chairman expressed delight that two companies were giving their time and resources free of charge to complete the path in the cemetery. When asked why it was on the agenda, it was explained that the parish council have to follow protocol, that no individual councillor has the authority to act on behalf of the council without first been given a resolution to do so.

Old Cemetery Path - Cllr Nunns - offer of free tarmacing/works, to discuss and decide thereon

Following a lengthy discussion a resolution was passed for the works to be carried out by BDS Yorkshire Ltd and Newlay Asphalt Ltd, both offering a free of charge service and supply of materials to re-tarmac the full length of the path in the old part of the cemetery and part of the top smaller path. Mr Peter Middlewood has offered to spray the weeds along the path prior to tarmacing, free of charge. Insurances have been submitted and Cllr Nunns has confirmed that all safety precautions will be implimented by the tarmacing companies.

Before commencement of the works, dates to be confirmed with the Clerk to ensure no burials are scheduled to take place.
